



1. The draft for Revision of existing Bye-laws for the Regulating of the Erection of any Enclosure, Fence, Tent, Awning or other Temporary Structures of whatsoever material or nature on any land situated within the Babina Cantonment, which the Babina Cantonment Board proposes to make in exercise of the powers conferred by sub section (18) of section 348 and section 349 of the Cantonments Act 2006 (41 of 2006) is hereby being published, as required by sub-section (1) of section 350 of the Cantonments Act, 2006, for the information of all persons likely to be affected thereby, and notice is hereby given to all effected persons that the said draft Bye-laws will be taken into consideration by Cantonment Board, Babina after the expiry of fifteen days from the date of publication of this notice.
- 2 Any objections or suggestions which may be received from any person with respect to the said draft before the expiry of the period of fifteen days stated above will be considered by the Babina Cantonment Board.
- 3 Detailed Draft By-laws for Revision of Bye-Laws for the Regulating the Erection of any Enclosure, Fence, Tent, Awning or other Temporary Structure of whatsoever material or nature on any land situated within the Babina Cantonment has been uploaded on Babina Cantonment Board website <https://babina.gov.in/> and also placed on the Office Notice Board for perusal of the general public.

Any person who intends to file objections/suggestions in respect of the draft for Revision of Bye-laws for the Regulating the Erection of any Enclosure, Fence, Tent, Awning or other Temporary Structure of whatsoever material or nature on any land situated within the Babina Cantonment may submit the same in the office of the Cantonment Board, Babina in person or by post or by email on ceobabi-stats@nic.in on or before the expiry of a period of fifteen days from the date of publication of this notice.

BABINA CANTONMENT

DRAFT REVISION OF BYE-LAWS FOR REGULATING THE ERECTION OF ANY ENCLOSURE, FENCE, TENT, AWNING OR OTHER TEMPORARY STRUCTURE OF WHATSOEVER MATERIAL OR NATURE ON ANY LAND SITUATED WITHIN THE CANTONMENT AND THE FEES CHARGEABLE IN RESPECT THEREOF.

The Bye-laws for regulating the erection of any enclosure, fence, tent, awning or other temporary structure of whatsoever material or nature on any land situated within the Cantonment and the fees chargeable in respect thereof in the Babina Cantonment framed under clause (18) of section 348 and section 349 of the Cantonments Act 2006 by the Cantonment Board, Babina, namely:-

1. No enclosure, fence, tent, awning or other temporary structure of whatsoever material or nature shall be erected on any land situated within the limits of Babina Cantonment without the permission in writing of the Chief Executive Officer.
2. Permission to erect the temporary structure referred to in bye-laws (1) may be given by the Chief Executive Officer subject to such conditions and as user charge, as may be imposed by the Board in this behalf.
3. Permission under bye-law (2) may be given for a period not exceeding twelve months in each individual case and shall not be renewable.

Provided that the previous concurrence of the Defence Estates Officer shall be obtained in respect of areas not under the management of the Board.

4. Any person committing a contravention of Bye-laws shall on conviction thereof shall be punishable in accordance with the provisions of section 349 of the Cantonments Act 2006.
